Our teacher is offered several ways to participate in professional development ie. conferences, books , CD's , DVD's, online classes and internet webinars. They also participate in district, county and state teacher in-services. Funds were available to support teachers professional growth through the Educator Effectiveness grant for 2016-2018. In January 2019 a teacher without multi-grade level experience was hired to teach and so Individual mentoring and in-class coaching was provided four hours per week from January 2019 through December 2019 to provide tools, resources and information regarding multi-grade level classroom and time management. Also, school expectations and state standards were reviewed to ensure the continuity of the educational experience for the students.
